**Dates:** May 14 – May 16, 2025

**Times:** 9:15 – 10:15 AM and 3:15 – 4:15 PM

**Location:** Level 200 Foyer (Across from room 260) of the New Orleans Ernest N. Morial Convention Center (NOENMCC)

**Price:** One-Day Rental – Only \$750 per table. Three-Day Rental Special – Just \$500 per day when you book for three days!

### IMPORTANT DATES AND DEADLINES:

#### February 2025:

- Registration for the Career Fair begins!

#### April 7, 2025:

- The last day to register for a Career Fair table.

### Day of Event Details:

- Set up and check-in to the Career Fair area begins 45 minutes before each time block – 8:30 AM and 2:30 PM, respectively.
- At least one representative of your participating company is to be expected to be present at your assigned Career Fair table for the duration of the event.
- You will only be permitted to participate at your assigned table and no table swaps between companies are allowed.
- Please note that the Career Fair area will not be supervised by security at all times. If you would like to leave your signage and materials at your table, please do so at your own discretion.
- Canvassing or distributing advertising materials outside your Career Fair table(s) is not permitted. Signs, banners, posters, or flyers advertising a Career Fair table may not be posted or displayed at any location inside the convention center other than the exhibitor's booth or Career Fair table. Advertisements and promotional materials may not be displayed or distributed in the educational space at any time.
